IASCA Announces Big Advocacy Win

After more than a decade of lobbying Idaho Medicaid for a pediatric dentistry fee schedule increase, it has become a reality! On May 1, 2023, Idaho Medicaid is adopting the use of the Code on Dental Procedures and Nomenclature by the American Dental Association.

IASCA treasurer, Shane Ricks, and IASCA lobbyist, Tammy Perkins, played a vital role in winning this hard fought battle which will allow Idaho ASC's the opportunity to deliver care to one of our most vulnerable populations. Thank you!

The new methodology mirrors the professional schedule and payment is based on the procedures performed (D codes) and creates variability in payment. Based on an initial analysis, payments will are expected to increase an average of 82%. For example, a procedure that normally was reimbursed \$634.58 will now be an average of \$1067.60!

Idaho Legislative Update

Over half of the legislature was new this session, but that didn't stop the freshman from being heavily involved with creating and passing legislation. The session saw a lot of debate over school choice, improper materials in libraries, property tax relief, drag shows and transgender issues, abortion, and of course Medicaid costs.

There was a required five-year review of Medicaid expansion that was approved by voters in 2018. A few legislators introduced legislation to repeal the expansion program, but ultimately most legislators believed that to be too much of a risk so it didn't advance. In the end, the original Medicaid appropriation didn't pass the House, so JFAC had to go back and reduce the funding intended for the expansion program to get a passing vote in the House. The Senate then passed the reduced appropriation by only one vote.

While there were only a few provider rate increases, thankfully there were no provider reductions for the regular programs of Medicaid. However, the legislators did request that more cost containment measures be evaluated. HCR 9 was passed to begin that process with a Medicaid manage care legislative study. This information will be reported to them next session.

Finally, as session closed, Medicaid had the longawaited dental codes finished and said they would be effective May 1.
